

Memorandum of Understanding



Centre for Marine Science and Technology, Manonmaniam Sundaranar University, Rajakkamangalam, Kanyakumari District, Tamil Nadu, India – 629 005 and the Life Science Departments (Department of Zoology & Department of Botany) of Holy Cross College, Nagercoil, Kanyakumari District, Tamil Nadu, India – 629 004, Hereby Enter Into This General Agreement to Foster Mutual Co-operation in Education and Research.

- 1. The Parties agree to encourage the following exchange activities based on their respective academic and educational needs:
 - a. Guest lectures by faculty of Holy Cross for the students of CMST-10 hrs per year
 - b. Training on instrumentation to be given to the students of Holy Cross College, by faculty of CMST.
 - c. Collaborative research, hosting joint conferences and workshops.
 - d. Support to research scholars (using lab facility and reference material as per the norms of both institutions).
 - e. Any other academic exchange as may be agreed by both parties.
- 2. The implementation of each exchange program referred above will follow the guidelines established on mutual agreement by both the parties. Efforts will be made by both parties (individually or jointly) to find financial resources for carrying out the activities listed above.
- 3. Nothing shall diminish the full autonomy of either institution nor will any constraints be imposed by either upon the other in carrying out the agreement.
- 4. This agreement shall be in force for a period of 3 years from 2018 and is subject to revision or modification by mutual agreement. It is also understood that this agreement may serve as the basis of specific agreements to be developed at a later date. It is further understood that either institution may terminate the agreement at any time, although such action will only be taken after mutual consultation in order to avoid any possible inconvenience to either party.

5. Amendment to the MOU:

This Memorandum of Understanding may be amended in writing by mutual consent between both parties.
