M.1.2 S A Raja Pharmacy College (SARPC) located at Vadakkangulam, Tirunelveli District of the other Part.

#### M.2 Preface:

M.2.1 Whereas the Department of Zoology (HCASC) being the nodal institution responsible for teaching as well as performing a various biomedical research from natural sources. They have good laboratory and teaching infrastructure facilities.

- M.2.2 Whereas the SARPC has animal house facility approved by CPCSEA New Delhi along with good laboratory facilities and good infrastructures to develop the research activities and to undertake various research projects including preclinical studies, in India.
- M.2.3 It has been decided that (HCASC) and SARPC enter into by signing a Memorandum of understanding (MoU) to undertake collaborative research activities and animal studies (preclinical studies).
- M.2.4 Whereas both (HCASC) and SARPC are convinced about the mutual benefits of establishing formal linkage to develop new collaborative teaching programme and research in the area of preclinical research(research on animals). Now, therefore, in consideration of the preface and mutual covenants hereinafter contained, the parties hereto agree as follows:

## M.3 Scope and responsibilities:

- M.3.1 These two institutes after considering their objectives and strengths have agreed to have an understanding for collaboration in the following area of interest:
  - Conduct joint research and development projects in the areas of preclinical research.
  - To perform the PG and research scholars dissertation, thesis in the areas of animal activities and IAEC clearance.
  - Organize and participate in joint conferences/ workshops/ short term courses conducted by either of the organization.
  - Extend access to library and knowledge sharing facilities.

## M.4. Duration

M.4.1 This Memorandum of Understanding shall be valid for a period of five years from the date of signing of the same and thereafter can be renewed for further periods subject to such other terms and conditions as may be mutually agreed upon.

M.5.1 No modification to this MoU shall be binding unless made in writing and signed by both parties.
